**Fee Agreement and Authority to Represent**  
**Traffic Defense**  
**(\$100.00 due upon retention)**

I, the undersigned client (hereinafter referred to as "I," "me" or the "Client"), do hereby retain and employ **Dennis F. Wiggins, Jr.** and his law firm, **Dennis F. Wiggins, Jr., LLC, dba Baton Rouge Traffic Defense**. (hereinafter referred to as "Attorney"), as my Attorney to represent me in connection with the following matter:

**TRAFFIC TICKET DEFENSE**

1. **ATTORNEY'S FEES.** As compensation for legal services, I agree to pay my Attorney as follows: **\$100.00, online payment through the Baton Rouge Traffic Defense website** for Traffic Defense. This representation is a criminal representation and as such, the fee paid is earned upon payment and **NO REFUNDS** will be given. Upon payment, you have agreed to this Contract.
2. **COSTS AND EXPENSES.** **The nature of Traffic Defense tends not to necessitate costs and expenses**, however I agree to promptly reimburse Attorney for any amount paid on my behalf.
3. **NO GUARANTEE. I acknowledge that Attorney has made no promise or guarantee regarding the outcome of my legal matter.** Attorney has advised me that while **Baton Rouge Traffic Defense** attempts to seek dismissal in every case, the Attorney is authorized to accept an offer of reduction of the offense to a non-moving violation, seat belt ticket, or otherwise, and I, the represented Defendant, am **SOLELY RESPONSIBLE FOR THE PAYMENT OF ALL FINES**. I further acknowledge that Attorney shall have the right to cancel this agreement and withdraw from this matter if, in Attorney's professional opinion, I refuse to follow the recommendations of Attorney, and/or I fail to abide by the terms of this agreement, and/or if Attorney's continued representation would result in a violation of the Rules of Professional Conduct, or at any other time as or if permitted under by the Rules of Professional Conduct.
4. **LOUISIANA LAW.** This contract shall be governed by Louisiana law.
5. **TERMINATION OF REPRESENTATION.** I understand that I have the right to terminate the representation upon written notice to that effect. I understand that I will be responsible for any fees or costs incurred prior to the discharge or termination. At the time of any termination in the representation, I understand that I will be given an accounting for all fees, expenses and costs.
6. **ENTIRE AGREEMENT.** I have read this agreement in its entirety and I agree to and understand the terms and conditions set forth herein. I acknowledge that there are no other terms or oral agreements existing between Attorney and Client. This agreement may not be amended or modified in any way without the prior written consent of Attorney and Client.
7. **SEPARATE SIGNUP.** I agree that I have signed the Baton Rouge Traffic Defense online signup form and upon **PAYMENT**, I have received this copy of the Fee Agreement and Contract, explaining the nature of the representation and the terms thereof. The online signature and Payment shall constitute a signature and agreement to this Contract. An additional copy of this agreement is available upon request and may be delivered via Text, Email, Fax, Mail, Hand Delivery, or any other method that would reliably inform the Defendant of the Fee Agreement.
